

Sub: ICTE approval to Gandhi Nagar Engg. College . Gandhi Nagar . Gujrat for the academic year 1994-95.

I am directed to state that based on the recommendations of the central Task Force and manpower Task Force, the AICTE has approved the proposal for setting of Gandhi Nagar Engg. College, Gandhi Nagar, Gujrat, to conduct the following courses with intake capacity shown against each for the academic year 1994-95:-

The above approval is subject to fulfillment of specific and general condition as under:

Specific Conditions

- 1. The infrastructural and other facilities including faculty, equipment, books, etc. should be provided as per AICTE norms.
- 2. A Principal having qualifications, experience, etc. as per AICTE norms should be in position before admission of students.
- 3. One Professor and two lecturers in each discipline having qualifications, experience, etc. as per AICTE norms should be in position before admission of students.
- 4. The infrastructural and other facilities in terms of class rooms, tutorial rooms, labs, workshop, library, etc. as per AICTE norms for atleast First Year of the courses should be in position before actual admission of the students.

- 5. The infrastructural and other facilities in terms of building, labs, shops, books, etc. for subsequent years as per AICTE norms should be in position atleast six months in advance before actual start of classes of those years.
- 6. The teaching faculty strength should be available for each year of study well before the commencement of the course and this should be progressively raised by appointing Professors. Asstt.Professors and Lecturers as per AICTE norms maintaining the cadre proportion.
- 7. The Management should establish an Endowment Fund of Rs. 10 lakhs and Fixed Deposit Receipts should be mortgaged with the Director of Technical Education, Maharashtra. An amount of Rs. 5 lakhs should be deposited before actual admission of students and rest with in two years.
- 8. The approval is subject to the condition that the Management should produce immediately (i) a duly registered undertaking on a non-judicial stamp paper and (ii) an evidence of financial soundness to the AICTE, Delhi.
- 9. The AICTE scales of pay should be granted to the teaching faculty.
- 10. The institute should provide an evidence of availability of affiliation of the courses from respective university in their name before the start of session 1994-95.
- 11. The institute should get affiliation to the State Board of Technical Education before actual admissions are made for academic year 1994-95.

General Condition

- The Management including the Governing Body of the College shall be constituted, and its Chairman shall be appointed as per the guidelines of AICTE.
- 2. No new courses shall be started or an ongoing course shall be discontinued by the institution without the prior approval of the AICIE.
- 3. The intake in any of the approved courses shall not be altered by the institution without the prior approval of the AICTE.
- d. Adequate funds shall be available with the Institution to meet the financial obligations of recurring and non-recurring nature as prescribed by the AICTE, including Endowment Fund, as prescribed by the AICTE.
- 5. All infrastructural, instructional and other facilities shall be provided as per the AICTE norms prescribed from time to time.

Teaching and other staff shall be selected according to the procedure, qualifications, experience and pay scales as prescribed by AICTE from time to time, and that they shall be paid full salaries and allowances regularly and in time.

- 7. The tuition and other fees shall be charged as prescribed by the State Government within the overall, criteria/limits prescribed by the AICTE from time to time.
- 8. The institution shall not charge any Capitation Fee or domation for admission or other higher charges from the students/quardians of the students in any form.
- 9. Admissions shall be made on merits and as per the norms and guidelines of the AICTE.
- 10. The State Government policies for admissions of SC/ST, other weaker sections of Society etc., shall be followed by the Institution.
- II. Institution by virtue of the approval by AICTE shall not automatically become eligible to receive financial grants or assistance from the Central or State Governments.
- 12. Institution shall maintain records and books of accounts as prescribed by the Competent Authority.
- 13. The Accounts of the Institution shall be audited by Chartered Accountant or any agency authorised by the Competent Authority and shall be open for inspection by the AICTE or any body authorised by it.
- 14. The Institution shall be subject to a Special Audit and inspection as prescribed by the AICTE.
- 15. Institution shall furnish requisite returns as prescribed by Competent Authority/AICTE for ensuring maintenance of standards.
- 16. The Institution may be visited by an officer or a Committee of the AICTE or of its Regional Office from time to time to review the progress made by the Institution in fulfilling the conditions as laid down by the AICTE.
- 17. The Institution shall constitute a Planning and Monitoring Board (PMB) for the continuous monitoring of implementation of norms and standards of the AICTE. There shall be an evaluation of the Institution in a plan period by the AICTE.

The approval is further subject to full compliance with the SCHEME as prescribed by the Supreme Court in it Judgement dated 4.2.1993 with regard to WP(C) No.607 of 199 in the case of Unni Krishnan, UP and others etc. etc., V State of Andhra Pradesh and others etc., and late Judgements, and the related guidelines and criteria as make issued by the AICTE, UGC or the Central Government from time to time.

In the event of non-compliance of the guidelines, norm and conditions prescribed by the AICTE, the AICTE or a bod or person(s) authorised by it shall be free to take measure for withdrawal of the approval or recognition, withou consideration of any related issues and that liabilitie arising out of such withdrawal would be solely that of the Trust/Society and/or institution.

You are requested to kindly take appropriate action to implement the decision of the AICTE and communicate the progress made in this regard to the Western Regional Committee (WRC) of the AICTE under intimation to this office.
